

ANNUAL FINANCIAL REPORT FOR THE FIDUCIARY COLLECTIVE INVESTMENT TRUST DURABLE EQUITY TRUST FUND

This is an annual financial report provided to Participating Trust Representatives for trusts participating in The Fiduciary Collective Investment Trust ("Trust") for the period 1/1/2019 through 12/31/2019 as required by 12 CFR 9.18(b)(6).

Basic Financial Statement

The value of the fund, including receivables and subtracting liabilities, was \$30,536,698 at the end of the year, compared to \$15,613,178 as of the beginning of the year. During the year the fund experienced an increase in its nets assets of \$14,923,520. This change includes unrealized appreciation or depreciation in the value of Trust assets; that is, the difference between the market value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. Total unrealized appreciation was \$5,588,510.

During the year, purchases of \$24,230,260 were made while the sales of investments in the Trust resulted in proceeds of \$13,399,085 producing realized gains of \$656,592. The Trust had total income earnings of \$471,713 on investments.

Disbursements from the Trust during 2019 totaled \$7,131,577. Of this amount, \$117,225 is attributable to Trustee, Investment Management and Trust Service Fees. The remaining \$7,014,352 is due to liquidations from the Trust.

Investment Summary

All investments held in the Trust are common stocks and no investment was in default at the end of the year.
